

## Privacy Notice for System Leaders designated and affiliated with Kyra Teaching School Alliance TSA & Kyra Research School RS (Lead School: Mount Street Academy)

**System Leaders include Local Leaders of Education, Specialist Leaders of Education, Evidence Leads in Education**

### The personal data we may hold:

Personal data that we may collect, use, store and share (when appropriate) about system leaders includes, but is not restricted to

- contact information, date of birth, TRN (Teacher Reference Number),
- qualifications and employment records, including work history, job titles, working hours, training records, area of specialism
- records in relation to school to school support and your deployment in schools or activity on behalf of Kyra TSA or Kyra RS.

### Why we use this data:

We use this data to

- assess your suitability for designation to the role that you have applied for and suitability for individual deployments
- promote the system leaders affiliated with the Kyra TSA and RS on the website, through social media, publications and bulletins.
- share the skills set of system leaders with stakeholders, for you to undertake a school improvement activity, to maintain records of the activity you undertake on behalf Kyra Teaching School/Research School
- to undertake quality assurance of activity undertaken by Kyra TS & RS
- in order to report to funding bodies in relation to the activity of Kyra TS & RS.

### Our lawful basis for using this data

We only collect and use personal information about you when the law allows us to. Most commonly, we use it where we need to:

- Fulfil a contract that we have with you to designate and/or deploy you, to fulfil a contract with other stakeholders for you to deliver activity on behalf of Kyra teaching school / research school
- In the public interest as an organisation carrying out school improvement under our designation as a Teaching School.

Some of the reasons listed above for collecting and using personal information about you overlap, and there may be several grounds which justify Kyra TSA and/or Kyra RS use of your data.

## How we store this data:

We are committed to ensuring that your information is secure. In order to prevent unauthorised access, alteration or disclosure, we have put in place suitable physical, electronic and organisational procedures to safeguard and secure the data we receive and process during your designation.

We maintain electronic copies of your data. The information contained in this file is kept secure and is only used for purposes directly relevant to your designation as a system leader.

## Updating information

Please let us know if the personal information that we hold about you needs to be corrected or updated.

## Retention of data

Personal data that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes which relate to the time of your designation, and the period of time in which our activity in relation to the Teaching School and Research School grant funders, is evaluated, reported and audited.

We are required to report both successful and unsuccessful applications for system leaders (SLEs & LLEs) to the DfE we will retain application forms and interview records for a period of 5 years at which point we will securely destroy them.

## Data sharing

We may share information regarding your designation and the activity system leaders undertake on behalf of the teaching school and research school with:

- Department for Education, we are required to provide key information regarding the designation and activity of LLEs & SLEs to the DfE as grant funders or the Kyra Teaching School designation. - We will share you name, designation and profile on the Kyra TSA website & Kyra Research School website, LTT website.
- Schools and professional bodies looking to commission the work of system leaders.

- Suppliers and service providers – to enable them to provide the service we have contracted them for, such as paying your school of work for your deployment.

### Your rights

#### How to access personal information we hold about you

Individuals have a right to make a **‘subject access request’** to gain access to personal information that the school holds about them.

If you make a subject access request, and if we do hold information about you, we will:

- give you a description of it
- tell you why we are holding and processing it, and how long we will keep it for
- explain where we got it from, if not from you
- tell you who it has been, or will be, shared with
- let you know whether any automated decision-making is being applied to the data, and any consequences of this
- give you a copy of the information in an intelligible form.

You may also have the right for your personal information to be transmitted electronically to another organisation in certain circumstances.

#### Your other rights regarding your data

Under data protection law, individuals have certain rights regarding how their personal data is used and kept safe. You have the right to:

- object to the use of your personal data if it would cause, or is causing, damage or distress
- prevent your data being used to send direct marketing
- object to the use of your personal data for decisions being taken by automated means (by a computer or machine, rather than by a person)
- in certain circumstances, have inaccurate personal data corrected, deleted or destroyed, or restrict processing
- claim compensation for damages caused by a breach of the data protection regulations.

### Complaints

We take any complaints about our collection and use of personal information very seriously.
